## APPLICATION INSTRUCTIONS

### IF YOU ARE A.C.T.A.R. ACCREDITED:

1. Fill out the personal information. Write your ACTAR registration number on the appropriate blank.
2. Skip down to and read the Provisions section. If acceptable to you, sign and date the application form.
3. Enclose a check for one year's dues (\$60). (The \$15 will be waived.) Mail to above address.
4. You will be accepted as 'Reconstructionist' automatically.

### IF YOU ARE NOT A.C.T.A.R. ACCREDITED, BUT WOULD LIKE TO APPLY AS 'RECONSTRUCTIONIST'

1. Fill out the application form on the reverse.
2. You may substitute a copy of your resume/CV in lieu of filling out the Education/Training section.
3. Enclose photocopies of your college diploma and training class certificates.
4. Enclose photocopies of an actual accident reconstruction you have performed in the past. The copy includes photocopies of photographs and other documents used. The names, dates, and other identifiers may be obliterated. The sample case cannot be returned, but will remain part of the applicant's membership file.
5. Read the Provisions section. If acceptable to you, sign and date the application form.
6. Enclose a check for one year's dues plus the \$15 application fee (\$75 total). Mail to above address.

### ALL OTHER APPLICANTS:

1. Fill out the application form on the reverse.
2. You may substitute a copy of your resume/CV in lieu of filling out the Education/Training section.
3. Read the Provisions section. If acceptable to you, sign and date the application form.
4. Enclose a check for one year's dues plus the \$15 application fee (\$75 total). Mail to above address.
5. Designation as 'Investigator' or 'Associate' will depend on the applicant's level of training.

Annual dues are \$60. The review process involves the applicant's package being examined by several committee members. It is a slow and time-consuming process. Please be patient. In an effort to avoid delay in processing the application, follow the above instructions.
